DEATH TOLL RISING

Rain fury claims 256 lives in Kerala

M SARITA VARMA Thiruvananthapuram, August 16

DEATH TOLL IN in the second round offloodhavocin Keralahas crossed 87 as the state grapples with worst rain ravage in its history. From May 29, the ongoing monsoon season has robbed as many as 256 lives, said chief minister Pinarayi Vijayan.

Five bodies were recovered after landslide in Thrissur on Thursday, and more are feared trapped in the debris. More than 1,50,000 people are in relief camps.

Thousands of Kerala-bound travellers are stranded as Cochin International Airport stopped operations. Flights to Kochi were diverted to Thiruvananthapuram, Mumbai and Coimbatore. "For international flights, this (diversion) will require special dispensation which has been granted considering the emergency DGCA (Directorate General of Civil Aviation) is coordinating," Suresh Prabhu, Union civil aviation minister, said on Twitter.

Although Thiruvananthapuram International Airport and Kozhikode airport are active, the rail traffic in the state has drawn to a grinding halt.The Kochi Metro Rail Limited (KMRL) also suspended its operations, after its yard was submerged in the flood waters.

"The state is going on red alert in all 14 districts on Thursday. Almost all villages are affected, either by floods or landslides. I have appraised Prime Minister Narendra Modi of

BMC gives nod for goat slaughter in courtroom on Bakr-Eid, HC slams its 'erroneous' system

PRESS TRUST OF INDIA Mumbai, August 16

THE BOMBAY HIGH Court on Thursday slammed the Mumbai civic body's "erroneous" online system for granting permission for animal slaughter in the city this Bakr-Eid, after a petitioner claimed that some lawyers had managed to secure nod under fictitious names to sacrifice five goats inside a courtroom.

The high court observed that the Brihanmumbai Municipal Corporation's online mechanism was "ridiculous" as it was granting permission "without any verification and application of mind" and directed it to take corrective steps, following which the civic body told the court that it will stop the process till Monday, the next day of hearing.

The BMC made the sub-

mission after a petition by a local trust questioned the way in which the civic body had been granting permission through an online system this year for slaughter of goats and

To prove the point, the petitioner's lawyer, advocate Sujay Kantawalla, produced copies of such permissions for Bakr-Eid that some lawyers from the court had secured against fictitious names and

One of the lawyers had posed as Neil Armstrong, and secured permission to slaughter five goats inside courtroom No. 13 of the HC, where the present petition is being heard by a bench of justices AS Oka and RI Chagla.

Kantawalla also informed the bench that lawyers had secured permission for slaughter of animals inside four more courtrooms in the HC, including the courtroom of the Acting Chief Justice.

On perusal of such permissions, the bench observed that the civic body's online mechanism for grant of such permission was indeed erroneous, and "ridiculous".

"Thankfully, the permissions have not been sought in our names," justice Oka quipped in lighter vein.

"We have been accused of many things in the past, but never for this (slaughter of ani-

mals),"he added. The bench also observed that the civic body needed to take immediate corrective steps to set in order its system

for granting permission for

animal slaughter.

"This is ridiculous. Some members of the bar applied for permission for slaughter at various office places and shockingly, were granted permission. Permission was even granted for slaughter inside this court-

"Our attention is also brought to the consequent violations under the Prevention of Cruelty to Animals Act (which mandates that slaughter of animals can be carried out only at licensed abattoirs)," the judges said.

The bench also observed that the corporation needed to scrutinise or re-verify the applications for which permission had already been granted through the online system.

It directed the civic body to file a reply by Saturday explaining the corrective steps it plans to take.

The corporation initially defended the online system, saying all applicants had to pass through a second stage of verification at the time of taking the animals out of the

petitioners had approached the court just weeks before Bakr-Eid (which falls on August 22) when the online system became operational last month? The civic body, however, later relented and said the online system would be stopped till the next hearing, after the bench said that the civic body must concentrate on taking corrective steps instead of finding faults with the petition.
